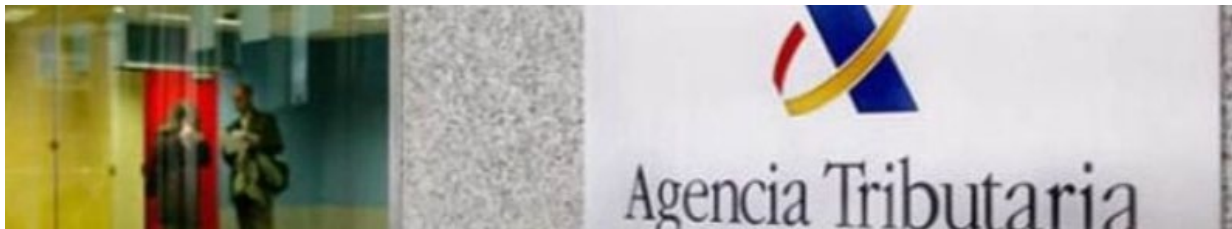
### One-stop shop for VAT in the EU extended

The **Financial Commission of the General Council of Economists** has published the latest **Financial Observatory - September 2020**, corresponding to the second quarter of 2020 and according to which, **as a result of the crisis arising from the pandemic, the Gross Domestic Product (GDP) will contract this year by 12.2 per cent**, while by 2021 a recovery of 7.2 per cent is estimated.
